Nearly three quarters* of those collecting benefits today are receiving a reduced benefit because they filed before their full retirement age, which is age 66 for most older Baby Boomers.

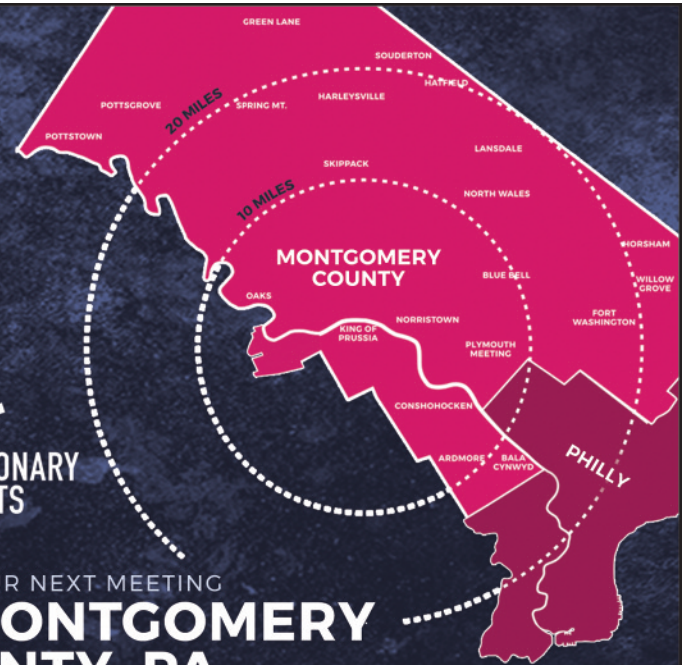
