Our team completed many quick turnaround inspections. The majority (80 percent +) of these inspections earned in the coveted "pass." In the cases where a system failed inspection, we offered design services. These services included replacement tank designs and new absorption area systems. In some instances, we assisted residents in connecting to the public sewer.

The year also saw steady demand for boundary surveys. Contrary to popular belief, a boundary survey is a complex, rigorous process. The process uses deed research, data, and electronic equipment to mark the property corners. A homeowner requests a boundary survey to know the limits of their property. Many homeowners have a boundary survey before a home improvement project. The survey ensures that new sheds, fences, and decks are on the resident's property.

Additionally, swimming pools made a splashing return. As municipal pools remained closed, residents missed having a place to swim outdoors. The rise in pool projects presented a unique opportunity to adapt our nearly 30-years of expertise. Today, pool construction requires a similar permit plan to building a home. Given the nature of the project, they required a quick turnaround and small budgets. We provided a range of services from topographic surveys to stormwater designs.






Our Team Grew
