"How about your customers?" Wentling asks. "You wouldn't think of not having a wheel-chair ramp or a handicap accessible bathroom, so what are your protocols for your hearing-impaired patrons? I certainly don't have all the answers, and every business and facility are going to be unique with their challenges, but I would certainly be happy to connect you with appropriate resources," he said.
