Learn about the Schuylkill River's Industrial Legacy, the Schuylkill River Trail and the many cultural and historic resources in Chester County.

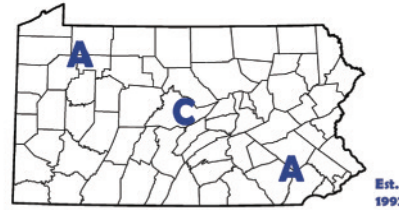

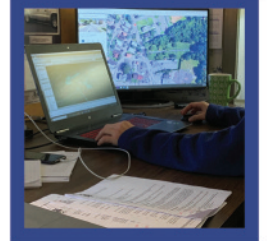
